

## **FAIRFIELD CITY COUNCIL MAJOR EVENT - TERMS AND CONDITIONS OF ENTRY**

**This is a notice erected under section 670 of the *Local Government Act 1993* (NSW) ('the Act').**

**All persons of any age who enter the premises of Fairfield Showground and the spaces in use for the Bring It On Youth Festival (the Event Site) must comply with these terms and conditions.**

1. Council as owner of the Event Site reserves the right to refuse entry to the Event Site by any person at any time or to remove persons from the Event Site who display disruptive or disorderly conduct or otherwise do not obey these terms and conditions.
2. For safety and security reasons, all persons must obey all signs around the Event Site / Council premises and all reasonable requests by staff.
3. Council is not responsible for loss or theft of or damage to personal property.
4. All children under the age of five (5) years entering the site must be accompanied and supervised by a person over the age of sixteen (16) at all times.
5. No person is permitted to smoke /vape on the Event Site / Council premises or within 10m of an entry gate.
6. No person entering the Event Site / Council premises shall carry out any form of commercial and/or business activity and/or enterprise within the Event Site / Council premises unless consent for this has first been obtained in writing from Council. If Council provides its consent to any form of commercial and/or business activity or enterprise, the person carrying out or responsible for the commercial and/or business activity or enterprise shall ensure that he complies with the terms of the consent issued by Council.
7. No person is permitted to sell alcohol unless supplied by the holder of a licence from Liquor & Gaming NSW authorising it to supply alcohol within the Event Site / Council premises.
8. No person is permitted to use or sell illegal drugs.
9. The following are not permitted without the prior consent of Council for the approved purpose:
  - (a) any photographic, video or audio recording equipment for any purpose other than private non-commercial purposes;
  - (b) any animal (other than a companion animal required for medical reasons with supporting evidence)
  - (c) any musical instruments, drone or other similar devices;
  - (d) any glass, party poppers, flares, fireworks, sparklers, knives or weapons of any kind (actual or perceived) or any other items deemed to be or which may be considered to be dangerous;
  - (f) any flag or banner which are not in English or for political, religious or offensive purposes without the prior written consent of Council.
10. Bags and any other items used to carry objects may be searched upon entry or at any time within the Event Site / Council premises.
11. All persons consent to being filmed and recorded by surveillance cameras at all times and their images being used for the enforcement of any law.

12. In consideration of being granted entry to the event each such person expressly acknowledges and agrees that (subject only to gross negligence on the part of Council staff or management being the direct cause of any loss, damage or injury to occur), each person will enter upon the Event Site / premises and surrounds and/or will participate in the programs, utilise the equipment and/or take advantage of the services offered therein, absolutely at his or her own risk, such that each person RELEASES AND DISCHARGES Council, its management, staff and contractors from all liability for loss, damage or injury which may be sustained by each such person in such manner or under such circumstances.

13. Council reserves the right to alter these terms and conditions at any time. Council reserves the right to take action to enforce these terms and conditions, for example, by prosecution.

**Section 660 of the ('the Act') provides that, among other things, it is an offence for any person to wilfully obstruct, by way of example, an employee of a local Council in the exercise of that person's functions under the Act.**

**Section 632 of the Act provides that any person that fails to comply with the terms of a notice or sign (for example, this notice, or any other notice properly erected under section 670 of the Act) will be guilty of an offence.**
