### CONDITION OF APPROVALS

1. Engineering Plan/Drawing detailing the site, including location of power/streetlight pole, pole setbacks from the driveway, footpath, kerb and gutter and other infrastructure, and utilities which must comply with Street Light Standard AS1158 shall be submitted.
2. The Street Lighting Design must comply with Street Light Standard AS1158.
3. Appropriate consultation with adjacent residents must be undertaken and their consent must be obtained.
4. A declaration from the Lighting Designer to confirm that the above conditions have been met during lighting design.
5. Evidence of public consultation and declaration from the Lighting Designer must be provided to Council with the request for NOCC sign off.
6. The Developer/Owner must complete and sign off the Traffic Class 5 section of NOCC before submitting to Council.
7. The applicant shall be responsible for the relocation or alteration of any public utilities and the costs of any alteration shall be borne by the property owner.
8. Application includes a non-refundable assessment fee (\$245.00 including GST).
9. The Applicant will be contacted for Credit Card phone payment following receipt of this application.
10. Please allow twenty five (25) business days for this application to be processed.
11. To minimise costs and delays the applicant will ensure that the Lighting Design and NOCC has met the above requirements before submission to Council. The applicant may need to pay additional fees, if revised design and NOCC are re-submitted.
